The Fast Rescue Boat was tested under witnessing of Bureau Veritas as per prototype tests report dated 2011-09-13, 2012-04-25, 2012-07-17 and 2012-08-02 on serial number 201201.

The laminate material of hull and rigid cover were tested as per fire retardancy test reports No. 142/A, flame retardancy test report No. 142/E dated 2009-12-10 and strength tests report No. CN53B960109A dated 1996-04-03.

- Each equipment, or batch of equipment, is to be supplied with its Manual(s) for installation, use and maintenance.

6. MARKING OF PRODUCT:

The fast rescue boat shall be marked with:

In particular Article 10.3 specifies that the wheelmark shall be followed by the identification number of the Notified Body involved in the production control phase (module D, E or F) and by the year in which the mark is affixed (4 digits or last 2 digits).
